Principal's Report: Bill Roach: There has been a student transcript issue because of programming problems with the switch from SASI to Power School. The guidance departments from all three charter high schools have been working with the liaison for the district and state to get this issue resolved. After a conference call, it was decided that there would be a meeting during Spring Break for the guidance people and the district to get it all settled.

Sports has had some problems with reserved fields being cancelled at the last minute and teams getting bumped and games needing to be moved or rescheduled. Met Monday with Greenville County Recreation Department and agreed to meet with them early next year so that the fields will be reserved. Between Greenville and Greer Rec, all of our needs are covered for Spring sports.

Hiring for next year has already started. Assistant principal has already been hired. Technical: three teaching positions have been filled. Interviewing will be completed next Friday.

Mike Sinclair and Skip Snow were elected to the board of South Carolina Association of Charter Public Schools.

Middle College National Consortium has an ambassador program and in April, Ryan Abdelnabi will represent our school, Tabor Barough will represent Brasier campus.

Development Report: Melanie Bargar: We have 282 students currently enrolled, 103 freshmen, 105 sophomores, 74 juniors, and 110 rising freshmen are enrolled for next year.

Five juniors and 5 sophomores tested for Compass to enroll in college classes next year.

We will be charging a supply fee of \$20 for all students next year: \$5 for a school agenda, and \$15 to go for Arts Intercession.

We are scheduled to speak at 2 or 3 more Rotary Club meetings and are attending Chamber events and are starting to be recognized.

Aug 13 from 2-5 PM will be our Fall for GMC event. We have invited Nicki Haley and Mik Zaes.

We are signed up to be a recipient for the Hands On Greenville work day April 30.
