2. Financial Statement for October 2023 – Elliot Figueroa presented the report.
 - i. The balance sheet has assets in the amount of \$1.66 million with liabilities of \$1.66 million with net equity of approximately \$1,200.00.
 - ii. The monthly net income was \$614.00.
 - iii. Mr. Figueroa stated that the revenue and expenses were identical to the previous month's financial statements.
 - iv. Eliot Figueroa moved to accept the financial statements. The statements were accepted unanimously.
3. New Business
 - a. Potential names of the school
