Charter School Website Content Requirements Guide

Purpose: This guide summarizes website posting requirements established by the South Carolina Charter Schools Act (including Act 123), South Carolina law, and applicable federal laws. It is intended as a reference to help schools identify required website content and the corresponding legal authority. Schools should use this guide when completing the **Charter School Website Compliance Checklist**.

Financial Transparency
